About this report

The PRI Reporting Framework is a key step in the journey towards building a common language and industry standard for reporting responsible investment (RI) activities. This RI Transparency Report is one of the key outputs of this Framework. Its primary objective is to enable signatory transparency on RI activities and facilitate dialogue between investors and their clients, beneficiaries and other stakeholders. A copy of this report will be publicly disclosed for all reporting signatories on the [PRI website](#), ensuring accountability of the PRI Initiative and its signatories.

This report is an export of the individual Signatory organisation's response to the PRI during the 2020 reporting cycle. It includes their responses to mandatory indicators, as well as responses to voluntary indicators the signatory has agreed to make public. The information is presented exactly as it was reported. Where an indicator offers a response option that is multiple-choice, all options that were available to the signatory to select are presented in this report. Presenting the information exactly as reported is a result of signatory feedback which suggested the PRI not summarise the information. As a result, the reports can be extensive. However, to help easily locate information, there is a **Principles index** which highlights where the information can be found and summarises the indicators that signatories complete and disclose.

Understanding the Principles Index

The Principles Index summarises the response status for the individual indicators and modules and shows how these relate to the six [Principles for Responsible Investment](#). It can be used by stakeholders as an 'at-a-glance' summary of reported information and to identify particular themes or areas of interest.

Indicators can refer to one or more Principles. Some indicators are not specific to any Principle. These are highlighted in the 'General' column. When multiple Principles are covered across numerous indicators, in order to avoid repetition, only the main Principle covered is highlighted.

At Pzena, our role as responsible stewards of capital is as important to us as our fiduciary responsibility to maximize risk-adjusted returns. We have always demonstrated a commitment to classic value investing: buying good businesses at low prices that are lagging their historically demonstrated, long-term earnings power. Through fundamental research, we seek to determine whether such earnings shortfalls are temporary or permanent. Each investment decision weighs risk and return by considering all issues material to a company's future prospects.

Throughout the firm's history we have believed that a company's environmental, social, and governance (ESG) issues can be material drivers of performance. In some cases, ESG factors have the potential to drive unacceptably wide or asymmetric ranges of long-term outcomes; while other issues, though not material today, could pose future risks if not adequately managed. Assessing the potential impact of ESG issues on a company is therefore critical to our investment process.

Once an investment has been made, we engage management on an ongoing basis. Through these conversations, and our proxy voting, we seek to exert a constructive, long-term-oriented influence on the trajectory of the company.

The ESG Committee decided to join the PRI back in 2018 and most recently decided to join the Sustainability Accounting Standards Board (SASB); it continues to evaluate whether to become a member of other ESG-based organizations.

Throughout the firm's history we have believed that a company's environmental, social, and governance (ESG) issues can be material drivers of performance. In some cases, ESG factors have the potential to drive unacceptably wide or asymmetric ranges of long-term outcomes; while other ESG issues, though not material today, could pose future risks if not adequately managed. Assessing the potential impact of ESG issues on a company is therefore critical to our investment process.

As we do with all key investment issues, significant ESG considerations are analyzed internally, discussed with company management and industry experts, and monitored. Each step of this process contributes to the team's determination whether to invest and, if we do, at what position size. Once an investment has been made, we engage management on an ongoing basis. Through these conversations, and our proxy voting, we seek to exert a constructive, long-term-oriented influence on the trajectory of the company.

While we do not restrict the investment universe, Pzena incorporates client-specific guidelines into custom screens. In addition, if we identify a severe ESG issue that management doesn't have a clear plan to remediate, we may avoid investing or exit an existing position altogether. These issues include use of child labor or involvement in human trafficking.

Our commitment to incorporating ESG into our investment approach drives us to enhance the way we look at ESG factors. For example, in 2018 we became a signatory to the Principles for Responsible Investment ("PRI") and added a dedicated ESG research analyst to the investment team.

- We hire service providers who make voting decisions on our behalf.

We take seriously our responsibilities as stewards of our client's capital and actively vote the shares of companies in which we invest on their behalf. Each proxy is voted in the best interest of our clients, defined as maximizing long-term shareholder value.

Proxy voting is integrated into our research process. We exercise proxy voting to highlight our views on management decisions, including ESG-related items, regardless of whether we agree with management's recommendation. If the ESG item up for vote could have a material effect on the business, we vote in line with what is best for the long-term interests of shareholders. ESG-related factors are typically among the most common items where we oppose management.

We subscribe to a proxy monitoring and voting agent service offered by Institutional Shareholder Services ("ISS"). ISS provides a proxy analysis, but we retain ultimate responsibility for instructing ISS how to vote proxies on behalf of each discretionary portfolio. Each proxy is reviewed individually, and the industry analyst covering the stock votes based on the merits of each issue. To support this evaluation, we have established a Proxy Voting Policy to ensure decision making is consistent with our fiduciary responsibilities and applicable regulations under the Investment Company Act and Advisers Act.

The ESG analyst also occasionally assists the industry analyst in making a vote determination, primarily on ESG items where either the specific issue falls outside of the scope of our Proxy Voting Policy or the industry analyst thinks it would be helpful to seek additional guidance. Our Director of Research is responsible for monitoring analyst compliance with voting procedures.
